

In exercise of the powers yested under Section 14(3)(a) of the National Council For Teacher Education (NCTE) Act, 1993, the Southern Regional Committee grants recognition to Dakshin Bharat Hindi Praction Sabha Basaveshwara B.Ed College, Hindi Bhavan, Vani Vilas Road, K.R.Mohalia, Mysore-570004, Karnataka for B.Ed Course of One year duration from the academic session 2000-2001 with an annual intake of 50 students, subject to fulfilling the following conditions:

- 7. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms
- The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.
- 9. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The performance appraisal report should inter alia give the extent
